TAX PAYMENT: Please mail payment to Richard Logterman, Treasurer, Town of Darien, N2826 Foundry Road, Darien Wisconsin. 53114. DO NOT USE PO BOX this will either delay or we may not receive your payment! Please check the address and make sure the amount is correct before mailing your tax payment. Enclose a self-addressed stamped envelope to receive a receipt. You may also pay in person at the Town Treasurer's office or use the drop box at the Town Hall, N2826 Foundry Road, Darien.

January 2017 Regular Office Hours: Tuesdays and Thursdays from 5 p.m. – 7 p.m. and January 30 & 31 from Noon to 4.

Real Estate Taxes may be paid in two installments, with the first installment due to the Town Treasurer on or before January 31, 2015. The second half must be paid to the County Treasurer on or before July 31, 2015. As a reminder the Walworth County Treasurer's office **DOES NOT** send out reminders for your second half payment. If you pay your taxes in full, the due date for payment is January 31, 2017. All Personal Property Taxes, Special Assessments, Special Charges, and Special Taxes of \$99.99 or less per parcel must be paid in full.

## Walworth County Sheriff's Department

For the month of October; the Walworth County Sheriff's Department responded to 338 calls in the Town of Darien. This would break down to 10.9 calls a day. Some of the calls include: EMS & fire calls, arrest person, sexual registry team, reckless driver, civil process, house checks, suspicious, business checks, extra patrol, traffic stop, 911 hangups, MVA-fatal, welfare checks, controlled burn, substation, abandoned vehicle, alarm, electronic monitoring check, fraud, attempt to locate, tree down, weapons, disorderly conduct – person, assist other departments, damage to property, domestic abuse, 911 misdial, open door/window, debris in roadway, civil process, livestock loose, pick up property, wire down, prisoner transport, bail jumping-misc, cmv inspection, road hazard, mental, car in ditch, abandoned vehicle, fire alarm, OVWI, dead deer, bar check, and battery-simple assault.
