Review, discussion, and possible action relating to a Proposal from the Town of Darien and Village of Darien Fire & EMS Subcommittee on Service

Discussion amongst the joint boards regarding the EMS Subcommittee Volunteer Pay. Members of the Joint Boards and Chief Justin Schuenke agreed the eight-hour Paid on Call blocks be adjusted a bit. Discussion by the Joint Boards concerning new ambulance fee charges; residents and non-residents. Chief Schuenke noted there was also a newly added ambulance fee for 'lift assistant for \$125.00 per assistant'. Chief Schuenke reported that the Darien Fire/EMS fees are in the same range of fees as neighboring municipalities.
